IMMIGRATION REFORM NEEDS YOUR VOICE!

Social Action Prayer & Call-In Day – Thursday, April 27, 2006

Immigration reform is presently being debated in the U.S. Congress. A recent statement by Bishop Anthony M. Pilla highlighted the importance of this debate, our position as Church, and the elements we should request our legislators to include in new legislation. He said, in part:

The outcome of the current debate in our nation regarding immigration reform is one that will have far reaching effects for years to come. By all accounts, our current policy is broken and fundamentally flawed. It does not serve us well as a people... In the gospel of Matthew, Jesus calls upon us to “welcome the stranger,” for “what you do to the least of my brethren, you do unto me.” (Mt. 25-35, 40)

Today, we have a wonderful opportunity to enact legislation that is humane and yet addresses legitimate economic, legal, social, and security issues...For quite some time now, we have advocated:

- *Policies that address the root causes of migration.*
- *Reform of our legal immigration system, including the adoption of an earned legalization program for undocumented workers and their families; a temporary worker program with appropriate protections for both U.S. and foreign workers; and reform of the family preference system, so families can be united in a timely fashion.*
- *Restoration of due process protections for immigrants to allow them to have “their day in court,” consistent with American values.*

Please call your senators and representatives on Thursday, April 27. Urge them to incorporate the above policies in their immigration legislation so that a new immigration system is created that reflects our deepest held values. Pray that we may all recognize and act upon our Gospel call to treat immigrants in a fair and compassionate manner.
